- a. 2019 Training Camp dates and locations
  - Shane proposed a new format for our training camps. He wants to have Two (2) “high tech” camps for Level 8–10. One in Northern CA and one in Southern CA for 2019. You must attend one of those high-tech camps to receive apparel for free. These camps are intended to build comradery and to be solid training events for athletes in our Region. We will still have compulsory, 6/7 and xcel camps throughout the Region. Those will not count for apparel. In addition, we will also have the Level 10 Showcase.
- b. Training Camp attendance requirements– It was voted to approve the Showcase as a camp approved for Apparel for 2018 for AZ clubs due to confusion about having a camp in AZ.
- c. 2018 Showcase: Change in format was discussed and approved in order to make smaller groups for the Showcase. The cost will be reduced to \$200.
