



Directions to Arenas

DECC and AMSOIL Arenas – Arena Phone 218-722-5573

350 Harbor Drive/Duluth, MN 55802.

From Twin Cities-Take I-35(North) to Duluth. Exit onto 256B 5th Ave West Lake Ave. Turn right at stop light onto Harbor Drive. Amsoil Arena and the DECC located on left hand side.

Coming from the North- Take I- 35(South) to Exit 256B Lake Ave 5th Ave West. Stay to the right hand side follow to 5th Ave West to the Stop light. Take left at stop light onto Harbor Drive. Amsoil Arena and the DECC located on the left.

Take I-35 to 21st Ave E. Go up 21st Ave E to Woodland Ave. Veer to the right. Follow Woodland Ave. to Anoka St. Turn right onto Anoka St. Go 1 block and turn right onto Allendale Ave. Fryberger is on the right hand side.

Take I-35 to Exit 254 27th Ave West. Turn away from the Lake onto 27th Ave West. Proceed to the stop light. Take left at the stop light onto Michigan St. Follow Michigan St approx. 2 ½ blocks. The Heritage Center is on the left hand side of Michigan St.

Take I-35 to Mesaba Ave. Follow Mesaba Ave to the top. Continue straight road will change and become Rice Lake Road Continue on Rice Lake Road Approx 3 blocks. Mars Lakeview Arena is located on the left hand side by Marshall High School.

Take I-35 (north) to 21st Ave E. Go up 21st Ave E to Woodland Ave. Veer to the right and continue on Woodland Ave to St. Marie St. Take left onto W. St. Marie St. follow W. St. Marie St. to University Drive follow University Drive to stop sign. The sports complex will be straight ahead. Take gradual right onto Ordeal Court follow Ordeal Court to first set of doors. Drop off players and equipment here. You will have to drive back for parking. Parking will be available in Lot G which was on your right as you first turned onto University Drive.

From Twin Cities -take I-35 (north). Exit onto 255B I- 535 / US 53 South to Wisc. Stay straight, continue over the bridge you will run right onto Hammond Ave. Stay on Hammond Ave to Belknap St. Turn left onto Belknap St. /US-2. Stay on Belknap St. to Catlin Ave. Turn right onto Catlin Ave. Stay on Catlin Ave approx. 4-6 blocks .Superior High School is on the left Wessman Arena is on the right.

From the North or Downtown Duluth- take I -35 (South) Exit onto 255B I- 535 / US 53 South to Wisc. Stay straight, continue over the bridge you will run right onto Hammond Ave. Stay on Hammond Ave to Belknap St. turn left onto Belknap St / US -2 follow Belknap St. to Catlin Ave. Turn right onto Catlin Ave. follow Catlin Ave approx 4-6 blocks .Superior High School is on the left Wessman Arena is on the right

Follow I-35 South .Take Exit 237 from I-35 South to MN -33 North in Cloquet. Continue on Mn-33 North. Take left onto Armory Road continue down and take left on Olympic Drive. Stay on Olympic Drive to the Arena.
