Birth Certificates-Thank you to everyone who scrambled to get birth certificates in at the last minute. However, next season, they will not be accepted last minute or out of order. Include birth certificate in registration process.

Safesport is changing. More involved with all youth sports. Starting 2019/20 season, Safesport is going to become a yearly requirement. All staff over 18 and players over 18 years of age will need to do Safesport before being rostered. This includes Midget teams. Safesport is still free. As of 4/15/19, Safesport is no longer a 3 part course, only a one part course.
