II. Treasurer's Report (Nate S)

Checking: \$ 81,115

Boosters: \$ 12,828

Items to Note: **\$3,000 deposited from sponsorships. \$2,00 received from registration. \$2,605 in Venmo before coaches stuff. Nate has a few other checks to deposit, as well. Jeremy reimbursed all 10u travel parents.**

III. Standing Items

A. Boosters (Casey) - **working on shirts, home weekend preparations, received \$2,000 from the Visitor's Bureau. Next booster's meeting is 3/26 @ 6 pm at Bonzers.**

B. NPLL (Dan) – **Next meeting is tonight at 8:30 pm. Dan sent out a draft NPLL schedule. Larua saw some suggested changes to make to the schedule. Dan will address these at the NPLL meeting. Update – this year there will be a boys JV team, not a girls JV team. This is per Fargo's proposal for a modified 6x6 or 7x7. In discussing with Coach Klay, he thought that was doable.**

D. Spring 2026 Season Planning/Updates

1. Registration Final Numbers - **119 total**

a) GNLL - do we have enough players at all levels for these weekends? **10u cancelled, 12u good, 14u (need about 5 players)**

b) 10U - will they be able to travel at all other than possibly Fargo? **Nate S. is going to call 8u and 10u kids to finalize any willingness to travel and what weekends (not 4/25-4/26 weekend).**

2. Pre-season Practice

a) Finalize 14U & Under schedule – **Board decided to utilize the BLC only for indoor practices and sign up for 2 weeks of**

indoor use. Starting 3/30 T, Th and the next week T, W due to BLC availability. 3/29 and 4/4 in Crookston is locked in for the 14u and lower. Discussed moving the Sunday practice to Saturday because a number of players are participating in the Artic pre-season camp that's every Sunday in March. Discussed moving all practices to Saturday. (Post-meeting discussion the board agreed to leave varsity practice as is since it's already scheduled and given out to parents. We will just move 14u and under to Saturday). 4/6 – T and W will have 8u start practice.

- D. PLL Group Tickets (Nate S) – Nate S. brought up an opportunity for lacrosse families to attend PLL together. Nate S. suggested sending out a link for

families to sign up for tickets. Anticipated date of August 29th for the quarter finals. May discuss this again at the next meeting.
