This is the individual application for the 2019 NKFL District League Tackle Football! We offer divisions in 3rd/4th and 5th/6th grade. The league will play 6 games and will be played primarily at the SportZone Complex. Other possible locations are Basehor, Lawrence or Manhattan. Players may only play on one roster during the session.

All coaches are required to have USA Football Certification completed by August 1, 2019. Players will provide their own mouthpiece, shoes, jersey, football pants w/pads and athletic supporter. All players must have a current physical (dated on or after May 1, 2019) turned in to the SportZone office prior to the first practice. Proof of grade and a copy of their birth certificate must be on file in the SportZone office by July 19, 2019. Practice with pads may not begin before Aug. 1st, 2019.
