- Nonprofit organization 501c3 status/update
  - New EIN issued
  - Submit to IRS and waiting approval.
  - Need a new bank account or need to repaper account.
- SFAA Meeting w/ various Athletic Associations held on 12/2.
  - Importance of SFAA is to have governance over various township Athletic Association organizations.
    - SFAA will have quarterly meetings.
    - Goal to raise \$25K/year.
    - Members of organization must be a 501c3 organization and provide monthly financial statements for review.
  - Cost of membership will be \$10/child.
    - Funds will be used for field maintenance and capital improvement projects of township fields.
      - SFYLA could request to have SFAA provide a wall ball structure.
- Reviewed roles and processes in the attached Calendar.
  - Add Uniform Try-on/equipment fitting at Top String
  - Add early December registration.
- Open at large positions or understudy positions available.
  - Girls' scheduler needed and Jody will reach out to parents after registration signups.
