



U07-U19 Club 2026-2027 Curriculum Overview

Participation with the PSC Academy program includes the following:

All training and game day coaching conducted by professional trainer(s)

Play in an appropriate division of the League decided by the Director of Coaching

Tournaments annually (as schedule allows; teams may play other events in lieu of tournament):

- **U07-U08:** 1 Tournament
- **U09-U12:** 3 Tournaments
- **U13-U19:** 4 tournaments

Team Training Sessions:

- **Fall:**
 - **U07-U14:** 2 times per week
 - **U15-U19:** starting around mid-October the teams will train once a week until HS season ends, then 2 times per week
- **Winter:** U07-U19 – 2 times per week
- **Spring/Summer:** U07-U19 – 2 times per week

Additional practices as set by the Director of Coaching

Annual Fee: The annual fee for the Club program includes everything listed above, plus all administration fees (Club registration league, ref fees, passes, etc.). It does not include fees for any additional tournaments, the uniform kits, additional equipment, specialized training, or cost to transport a player to/from practices or games. By accepting an offer to join PSC, you are acknowledging that you are responsible for the full fee and that all fees are non-refundable. The fees are as follows:

Non-Resident Fee: \$100 per player

By ordinance, the Township of Parsippany-Troy Hills assesses a \$100 fee to all non-resident participants for facility use and maintenance. This fee is billed separately.



Uniform Kit: PSC Academy teams wear Adidas uniform kits for both home and away games as well as for training. The PSC uniform kit is not included in the fee and will need to be purchased separately. Adidas changes kits on a regular schedule, so **ALL players** new and returning for the 2026-2027 season will need to purchase the full kits as defined on the uniform purchase website. Details on how to order the uniform kit will be provided after acceptance; payment is extra and due at time of purchase. Players are responsible to keep all uniform and training gear in good shape or will be required to purchase new ones.

Payment Schedule: You may pay the full cost of the program at time of acceptance or pay through installments based on the below payment schedule. Failure to maintain your account in good standing may result in players being restricted from practice and games until it is brought up to date.

Payment plan:

Upon Acceptance: a non-refundable deposit of:

- \$200 (\$300 for non-residents) for U07-U08 players
- \$350 (\$450 for non-residents) for U09-U11 players
- \$400 (\$500 for non-residents) for U12-U14 players
- \$5450 (\$550 for non-residents) for U15-U19 players

Payment Plan:

- 1st Payment: 25% of balance due on or before August 15, 2026
- 2nd Payment: 25% of balance due on or before September 15, 2026
- 3rd Payment: 25% of balance due on or before October 15, 2026
- 4th Payment: 25% of balance due on or before November 15, 2026

Please note: by accepting the position you understand that this is a year-long commitment. You are expected to attend and participate in ALL training sessions, matches and tournaments as set forth in the program plus any additional events chosen by the team's coach in conjunction with the Director of Coaching and Technical Directors. **Your acceptance of this offer also signifies you are fully accepting the financial obligation and are responsible to make full payment of all fees.** Your commitment also includes volunteering at the Parsippany Pride Tournament and Parsippany Soccer Club sponsored events where parent involvement is needed; otherwise players may be restricted from playing. As a non-profit club, Parsippany Soccer Club develops its Club, Premier, and Elite budgets based on total number of participants in each program and assuming revenues equals costs. As a result, no refunds will be granted and any surplus at the end of each fiscal year will be applied to the Club's Travel Enhancement Fund.
