The meeting was called to order at 6:09 pm by President Hastreiter.

UNFINISHED BUSINESS

Committees- Five total parents have volunteered for the two committees being formed: Pay Committee & Fundraising Committee. SH has assigned Mishia Hilliard, Amanda Trapp & Melissa Rouse (not present) for the Fundraising Committee. SH has assigned Toni Praus and Shonda Cundall (not present) to the Pay Committee. There was brief discussion about the responsibilities of these committees and the members that were present then elected to leave the Board Meeting.

Financials- Jonathan sent current P&L sheets via email. Toni Belle is on top of taxes for the club this year. There were several discounts and refunds that needed to be sent out concerning registration fees. All have been taken care of.

Registration- 119 total athletes registered. The break down is as follows:
U10= 17 total (minus 1 athlete potentially playing up), leaving 16 - 2 teams of 8
U12= 33 total (minus 5 kids moving up to 14 and plus 1 potential from U12), leaving 29 – 3 teams of 7 & 1 team of 8
U14= 39 total (plus 5 kids from U12, minus 1 moving up to U16), leaving 43 – 2 teams of 8, 3 teams of 9
U16/18= 30 (plus 1 from U14), leaving 31 – 3 teams of 8, 1 1 team of 7

There are 6 total athletes that are being moved by the Board. There is 1 athlete that requested to be moved prior to registration. The athlete whose parents requested they be moved must tryout in both age groups.

There are 3 total athletes whose parents denied medical attention when registering. The Board will let the coaches know when teams are established and it is known whose team these athletes will play on.

The Board may consider registering a U16 team this year. This will be different than what was done last year, but would be established once teams are created.
