



2026 USL Pre-Professional Player Registration

Proof of Identification (PID) - You will need to upload confirmation of one of the following forms of ID within the 2026 USL Pre-Professional Player Registration form. If the uploaded ID expired before the date of submission of your registration, your registration will be denied.

Some examples of acceptable ID's can be found below.

Passport (Valid, not expired)

Permanent Resident Card (Valid, not expired)

Employment Authorization (Valid, not expired)

Visa (Valid, not expired)

Birth Certificate

**** A driver's license is NOT an acceptable form of ID. ****

SafeSport Training

This Requirement is only for players born in 2008 or prior

When completing SafeSport Training, please use the same email address used within SportsEngine to better connect the two platforms.
