“USL Spokane Back to School Giveaway” Sweepstakes

NO PURCHASE NECESSARY TO ENTER OR WIN.

The USL Spokane Back to School Giveaway (the “Sweepstakes”) is sponsored by United Soccer Leagues, LLC (“Sponsor” or “USL”) and governed by these official rules (the “Official Rules”). ENTRANTS

Individuals who are eighteen (18) years of age or older may enter. Employees and immediate families of employees of the Sponsor and its member clubs are not eligible to enter. Sponsor reserves the right to verify the eligibility of each entrant (“Entrant”).

HOW TO ENTER

You can enter the Sweepstakes by visiting <https://gleam.io/snj64/usl-spokane-back-to-school-sweepstakes>, or by scanning the unique QR code presented at one of the local events throughout the month of August. Once on the page, fans must fill out all required form fields, and will have the opportunity to take actions to gain entries. Fans can enter six (6) different ways for up to 14 total entries. Point values and actions are indicated on the landing page.

Maximum limit of one entry per Entrant per email, regardless of method of entry. All entries must be received by the end of the Sweepstakes Period to be valid. Incorrect or incomplete entries are void. Any attempt to obtain more than one (1) entry per day by using multiple/different email addresses, identities, registrations or logins, or any other methods may void the entries and Entrant may be disqualified from the Sweepstakes. Any use of robotic, repetitive, automatic, programmed or similar entry methods or agents (including, but not limited to, sweepstakes entry services) will void all entries by Entrant. In the event of a dispute as to any online entry, the authorized account holder of the email address used to enter will be deemed to be the Entrant. Potential winner may be required to show proof of being the authorized account holder.

WINNER SELECTION

Three (3) winner(s) will be chosen by random drawing of all eligible entries during the Sweepstakes Period. For each action taken, the indicated number of entries will be added to the pool. Fans can enter six (6) different ways for up to 14 total entries. Winners will be notified by Sponsor via email on or about September 1st. Each Entrant is responsible for monitoring his/her email account for prize notification and receipt or other communications related to this Sweepstakes. Decisions of the Sponsor in the selection and determination of prize winner and all matters relating to this Sweepstakes are final and binding.
