Jason Reynolds- MAHA Update

Anticipating pressure towards Lansing/Governor towards getting rinks open. MAHA working daily to get communication to Governor about safety plans to open rinks. MAHA and USAH have lobbyists working for us to gain support for opening rinks.

Jason authored 5 page proposal with video content showing safety protocols that would help to keep hockey players safe and submitted to Lansing for review.

Jason reported committee meetings on youth sports taking place this week that include MHSAA and Pat Kelleher from USAH.

MAHA will allow teams to roster and travel to areas that have been approved for opening. MAHA will require travel log for teams traveling throughout Michigan and out of State to keep track of players locations in case of an outbreak.
