2019-2020 Volleyball Club Season

Additional Terms of Enrollment Contract with SSVBC

1. **Supportive Attitude Toward Club and its Staff:** Parents or guardians who enroll a child/athlete at South Sound Volleyball Club agree to support the Club's philosophy and core values. The Club reserves the right to dismiss an athlete whose parents or guardians repeatedly demonstrate what in the opinion of the Directors and Coaches of the Club has an uncooperative or destructive attitude toward any coach, director or staff member or toward the club itself.
2. **Compliance with SSVBC Rules and Regulations:** The undersigned parents/guardians have read and agree to accept the rules and regulations of the Club as stated in the current Handbook (available online). Disregard of or noncompliance with the rules and regulations of the club may result in the athlete's dismissal. Rules may be changed during the club year by the Directors or club administration.
3. **Good Standing through August of 2019:** The parent and/or guardian of the athlete is responsible for ALL DUES (including uniforms) and TRAVEL. Please see Travel section in Handbook. Payments will be made on time. If the athlete and parent/guardian make all payments on time the club will report them as "Good Standing" with the region by August 2020.
4. **Involuntary Dismissal:** The Club reserves the right to dismiss any athlete whose presence at SSVBC practices, tournaments and /or social media, in the judgment of the Directors/Coaches, is detrimental to the SSVBC community or to an effective positive learning environment.
5. **Accounts Must Be Kept In Good Standing:** Tuition and travel, if applicable, will be set up online, and each member needs to register and have an account. In the event that an account becomes 15 or more days past due or that tuition liability becomes due under Page (9-11) of the handbook, the undersigned parents, /guardians agree to pay the club's expenses of collection including, without limitation, attorneys' fees and costs. Interest on accounts that are 30 or more days past due will be assessed at 1.5% per month. The club reserves the right to temporarily deny attendance to, or to dismiss, an athlete whose family's account is 30 or more days past due. If the Club dismisses the athlete, the parents/guardians continue to be responsible for tuition and fees as set forth in page (9-11) of the handbook. An athlete and family will be reported to USAV and reported in bad standing, if they fail to pay for tuition and fees as stated below. Being reported in bad standing means that an athlete and family will not be able to try out for another club season until the balance is paid. Once the account is paid in full, the club will release the athlete from "not in good standing."
6. **Tuition and Travel Dues Liability:** The undersigned parents'/guardians' obligation to pay the tuition and fees, including travel fees, for the full 2019-2020 club year becomes unconditional after December 15th. No portion of such tuition or fees, paid or outstanding, will be refunded, nor will the obligation to pay such fees be cancelled in the event of absence, withdrawal, or dismissal of the athlete from the club, after December 15th, 2019). If after December 15th, 2019, if the athlete is absent due to a medical or other leave, the undersigned parents'/guardians remain obligated to pay the tuition and fees for the full 2019-2020 club season. An athlete who is being withdrawn by the athlete's parents/guardians will only be considered to have been withdrawn upon receipt of written notification of withdrawal by the Director of Finance and the Club Directors. If the athlete withdraws after Dec. 15, 2019, the undersigned parents'/guardians remain responsible for 100% of tuition and fees which include travel fees for the 2019-2020 season. The parent or guardian will also have a \$500 withdrawal fee due at time of dismissal,

quitting or leaving the team for any reason. **TRAVEL:** The club must be notified in writing by Dec.15<sup>th</sup> of 2019, if an athlete cannot travel with the team to an away tournament. If the club and its directors are not notified in writing, the parent or guardian is responsible for all fees for travel.

7. **Payment Obligations:** The undersigned parents/guardians understand and agree that when an athlete is withdrawn or is dismissed from the club during the club year, or when the athlete is withdrawn by the parents/guardians before the club year begins (Dec. 1), it is extremely difficult to determine the amount of damages that the withdrawal or dismissal will cause to the club. Therefore, after Dec. 15<sup>th</sup> 2019, parents or guardians are responsible for the tuition in full, travel fees and a \$500 withdrawal fee. If parents or guardians have signed a contract and withdrawal before December 15th, 2019, they will not be responsible for tuition or travel fees but will instead be responsible for the \$500 withdrawal fee only.
