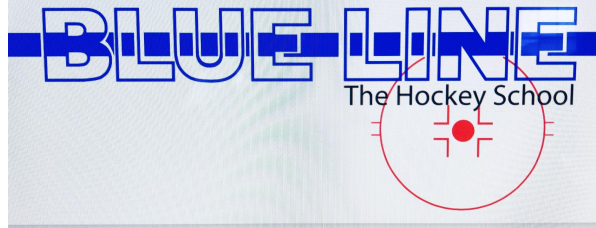
Medical Authorization & Indemnification
