2. All teams must be an USA Softball registered team for the current year and in good standing with the USA Softball of Wisconsin.
3. Tournament Director may negotiate fees with umpires and schedule umpires as needed. The tournament shall use USA Softball registered umpire and have the right to utilize local umpires.
4. Team trophies must be bought from the USA Softball of Wisconsin. All other awards are the responsibility of the Tournament Director and host site.
5. All softballs must be approved by the USA Softball of Wisconsin.
6. USA Softball rules and roster guidelines must be followed.
7. The tournament director may offer travel money. All travel money and entry fees for teams that advance are the responsibility of the tournament director and host site.
8. The USA Softball of Wisconsin Board of Directors will award the tournament site. Bidding does not guarantee a single bid will be accepted.

I understand that if we are awarded the above tournament, we agree to abide by the conditions that are set forth in the USA Softball of Wisconsin Code. We agree to promote and sell those products and services as authorized by the USA Softball of Wisconsin Board of Directors, and to register all of our umpires and teams that participate in our softball program.
