 - ii. Majority of families will be staying at Holiday Inn
- c. Volunteers – Scoring, Loading, Setup
 - i. Teams will be created Friday morning.
 - ii. Top shooters will be starting first (SLP is shooting second)
 - iii. Make sure shooters are drinking plenty of water – promote no Gatorade or any sugar drinks.
 - iv. Team will be located on West end.
 - v. Blaine has 20 kids. We shoot at approximately 10:30 (we have 30 kids). Will be a long day.
 - vi. Hope that when last shooters are shooting, we will have families that stay around for those last shooters for support.
 - vii. Coaches will not keep score.
 - viii. Umbrellas will need to be brought.

 - iii. Allows for 1 optional practice ahead of time.

 - iv. Waiting for Metro Closing Notice - what will our options be.
 1. We are currently penciled in at Forest Lake
 - v. Multi-sport shooters – how do you handle this?
 - vi. Young shooter (parents /grandparents driving) vs Driving shooters
 - vii. Need to look at the whole picture not just individual issues.
 1. Location
