_____ I, individually or on behalf of my child/ward, understand, acknowledge, and accept the scope, nature, and extent of risks involved in my participation in activities at Meachem Ice Rink. I understand and acknowledge the risks inherent in ice sports, including but not limited to ice hockey, figure skating and ice skating, and voluntarily and freely choose to incur such risks.

_____ I, individually and/or on behalf of my child/ward, understand and acknowledge the highly contagious nature of bacterial and viral diseases including but not limited to the 2019 novel coronavirus disease (COVID-19), MRSA, and influenza [collectively, the "Disease") and the risk that I/my child/ward may be exposed to or contract the Disease by being on the premises or engaging in these activities. I understand and acknowledge that such exposure or infection may result in serious illness, personal injury, permanent disability, death, and/or property damage. I understand and acknowledge that this risk may result from or be compounded by the actions, omissions, or negligence of others, including City employees, agents, officers, volunteers, and authorized representatives. I understand that while the City has implemented preventative measures designed to reduce the spread of the Disease, the City cannot guarantee that I/my child/ward will not become infected with the Disease while on the premises or engaging in these activities and that being on the premises or engaging in these activities may increase my/my child's/ward's risk of contracting the Disease. Notwithstanding the risks associated with the disease, I acknowledge that I/my child/ward am/is voluntarily entering the premises or participating in these activities with knowledge of the dangers involved. I/my child/ward hereby agree(s) to accept and assume any and all risks of personal injury, illness, disability, death, and/or property damage related to the disease, arising from my/my child/ward being on the premises or engaging in the activity, whether caused by the ordinary negligence of the City or otherwise.

_____ I, individually or on behalf of my child/ward, hereby release, discharge, indemnify, and hold harmless the City of Syracuse, its officers and employees, heirs, executors, administrators, successors and assigns from all actions, causes of action, suits, debts, dues, sums of money, accounts, reckonings, bonds, bills, specialties, covenants, contracts, controversies, agreements, promises, variances, trespasses, damages, judgments, extents, executions, claims, and demands whatsoever, in law, admiralty or equity, which against the City of Syracuse, I, my heirs, executors, administrators, successors, and assigns ever had, now have or hereafter can, shall, or may have, for, upon, or by any reason related to or arising from my use of Meachem Ice Rink.

_____ I, individually and/or on behalf of my child/ward, agree that the invalidity or unenforceability of any provision(s) of this General Release shall not affect the validity or enforceability of any other provision of this General Release, which shall remain in full force and effect.
