USL Academy Finals Bracket Challenge Sweepstakes

- One (1) winning team for each of the 15 matches in the USL Championship Playoffs

Each entrant must then enter each of the following data points to be eligible for prize.

- First Name
- Last Name

- Date of Birth
- Zip Code
- Favorite USL Club

Maximum limit of one entry per Entrant per email address, regardless of method of entry. All entries must be received by the end of the Sweepstakes Period to be valid. Incorrect or incomplete entries are void. Any attempt to obtain more than one (1) entry per day by using multiple/different email addresses, identities, registrations or logins, or any other methods may void the entries and Entrant may be disqualified from the Sweepstakes.
