As partial consideration for St. Joseph Church in Township of West Orange (the "Church") providing ("Participant") _____ with the opportunity to participate in the **Fall & Winter Basketball Activities**; I, _____ with an address of _____, as parent or guardian of Participant, for myself and on behalf of my spouse or partner, hereby (1) covenant and agree that Participant and I will abide by all rules and regulations of the Church applicable to participation in the RCBC, INC and Brandon Skills Programs, including compliance with all COVID 19 limitations and notices;

(2) acknowledge and agree that there are foreseeable and unforeseeable risks inherent in participation in RCBC, Inc and Brandon Skills Program and that the Church makes no representation or warranty regarding any risks or hazards, or lack thereof, associated with participation in the Program, and;

(3) participant and I release St. Joseph Church, RCBC Inc, Brandon Skills, its officials, departments, employees, volunteers, contractors, insurers, including the Amateur Athletic Union (AAU), its owners, employees, volunteers and subcontractors from and against all claims, losses, costs and damages arising from Participant's participation in the Program, including but limited to the risk associated with exposure to and contraction of the COVID 19 virus.

(4) I also represent, covenant and agree that Participant has been cleared by his/her physician to participate in the Program and further, that if Participant suffers any injuries or damages as a result of his/her participation in the Program, my sole remedy shall be to turn any associated medical bills over to my health insurance carrier for payment.

(5) I further agree that if a medical emergency should arise and I cannot be reached immediately at the contact numbers listed below, I hereby grant emergency medical personnel to take whatever steps he or she deems necessary to safeguard the welfare of Participant.

Pledge

Given that we are indoors, let’s make more explicit what I think is obvious. Everyone is signing up to protect one another according to the following pledge...

- I will wear a mask/face covering at all times when in public places, both indoors and outdoors, as required by health and school authorities (you do not need to wear a mask once you are in the gym)
- I will wash my hands frequently and thoroughly (for 20 seconds, minimum), especially after contact with surfaces and items in public areas, after eating, coughing, sneezing, or wiping my nose
