With the new guidelines in effect **July 2, 2020** the Saints ASC expects that all participants, parents and guardians follow the health protocols put in place by **Executive Order GA 29**.

- All players must self-screen and not exhibit any of the following symptoms in order to participate in the scheduled
- practice:

▫ <i>Cough</i>	▫ <i>Sore Throat</i>
▫ <i>Shortness of breath or difficulty breathing</i>	▫ <i>Loss of taste or smell</i>
▫ <i>Chills</i>	▫ <i>Diarrhea</i>
▫ <i>Repeated Shaking with chills</i>	▫ <i>Feeling feverish or a temperature greater or equal to 100 degrees F</i>
▫ <i>Muscle pain</i>	▫ <i>Known close contact with a person who is confirmed to have COVID-19</i>
▫ <i>Headache</i>	▫

If you, your player, or anyone in your household is experiencing symptoms, please notify your coach and keep your player home. The health and well-being of our Saints ASC families is our top priority and to mitigate the risk of a COVID-19 outbreak in the Saints ASC.
