Masks must be worn at all times while in race arena except while racing.

All FAST Race U8-U19 and Seniors, and General athletes U12-U19 and Seniors will start from the upper start (top of Phoenix).

U8 and U10 General Entry athletes, and all snowboarders will start from the lower start (bottom of Phoenix).

Running order as follows.

- From top start: Ability (U14+) Women, then ability Men, then U8, U10 then U12 Women, then U8, U10 and U12 Men.
- From lower start: U8 then U10 Women followed by men in the same order.
- Then Snowboarders women youngest to oldest followed by men.


All races will be based on a 2-run, combined time race.

All U8-U12 and General Entry athletes should inspect with a coach. All inspection groups must maintain a minimum of a 3-gate space during inspection.

Covid agreement must be completed by all participants within 24 hours of the event.




