The Annual Meeting was called to order by President Brad Sileo at approximately 7:08 p.m.

## **Minutes**:

• The minutes from the 2018 annual meeting were reviewed by the attendees. A motion was made to approve the minutes. The motion was seconded and the minutes were then approved by voice vote.

### **Treasurer's Report:**

- Dave Speer presented the treasurer's report. Dave stated that the organization's finances are in good shape. Revenue for 2018-19 was up 7.1%, while expenses were down 0.1%.
- Dave stated that due to the positive state of the finances, he is recommending that the fundraiser for 2019-20 not be made mandatory.
- It was noted that the organization has set up a Financial Review Committee so that multiple board members see and review the organization's finances.
- Reconciliation reports and bank statements were made available during the meeting for any members wishing to review them.
- Discussion was held regarding whether the organization should seek an audit of its finances. No votes were taken.
- It was noted that the 2018-19 board voted to keep team fees flat for 2019-20.

#### **Executive Committee Reports:**

- 2019-20 Tryouts:
  - o Ed Gaussa provided the dates and times for player tryouts for the 2019-20 season:
    - May 20: 5:20 p.m. to 6:20 p.m. for goalies only (MS and High School).
    - May 21: 5:30 p.m. to 6:40 p.m. (MS); 6:50 p.m. to 8:00 p.m. (HS).
    - May 22: 5:30 p.m. to 6:40 p.m. (MS); 6:50 p.m. to 8:00 p.m. (HS).
    - May 23: 5:30 p.m. to 6:40 p.m. (MS); 6:50 p.m. to 8:00 p.m. (HS).
  - Ed stated that the Varsity and JV coaches will run the high school tryouts and will assist the MS coaches in evaluating for MS tryouts. An independent goalie evaluator will be brought in to provide feedback on the goalies.
  - o It was noted that the registration portal is open.
  - A question was raised regarding whether the Varsity assistant coaches will be retained. Ed stated that he will be meeting with the head coaches in the future to discuss the coaching staffs.
- 1 or 2 JV Teams:
  - Discussion was held regarding whether the organization will field one or two JV teams for the 2019-20 season.
  - o It was noted that a final decision cannot be made until registrations and tryouts are complete because the number of skaters available is not yet certain.
  - Discussion was held regarding roster sizes for all high school teams in both scenarios.
- Varsity Placement—AA or AAA:
  - Discussion was held regarding the placement of the Varsity team for the 2019-20 season.
  - It was noted that PIHL uses a "competitive formula" which takes into account each team's prior three seasons and strength of schedule. That formula provides a recommended placement. PIHL has not completed that process yet, and likely will not do so until June.
  - O Discussion was held regarding whether the organization should petition to move up to AAA if PIHL recommends placement in AA.

  running. After votes were collected and tallied, Russ Ball was declared the winner of the
  election for Director—At Large.
- A vote by written ballot was conducted for the contested position of Director—PIHL
  Representative. In addition to the two existing nominees, the membership at the meeting was
  asked if anyone else was interested in running for the position. No additional members
  showed interest in running. After votes were collected and tallied, Dan Sinclair was declared
  the winner of the election for Director—PIHL Representative.
- For the position of President, the membership was asked if anyone in attendance at the meeting was interested in running for the position in addition to Brad Sileo, who had already been nominated. No one indicated any such interest. The membership was then asked a second time if anyone in attendance at the meeting was interested in running for the position. Again, no one indicated any such interest. Accordingly, Brad Sileo was declared the winner of the election for the position of President.
- For the position of Treasurer, the membership was asked if anyone in attendance at the meeting was interested in running for the position in addition to Dave Speer, who had already been nominated.
