Financial Update:

- September was a net negative month of \$7,992.82. This was due to the processing of \$1,200 in Rec Babe Ruth refunds. Uniforms costs for fall were paid at \$3200. Field supplies for next season came out as well. Resulting in YTD net income of \$13,160.

Travel Update:

- Travel Tryouts Feedback. Tryouts went well. It was discussed if we should consider adding timed run to evaluate speed of participants or adding back in pitching and catching. Makeups scheduled for Friday 10/18/24 at 5:30pm.
