USL League One Playoffs presented by Terminix Bracket Challenge

HOW TO ENTER

You can enter the Sweepstakes by making the following selections:

- One (1) winning team for each of the 7 matches in the USL League One Playoffs

Each entrant must then enter each of the following data points to be eligible for prize.

- First Name
- Last Name
- Email
- Date of Birth
- Zip Code
- Favorite USL Club

Maximum limit of one entry per Entrant per email address, regardless of method of entry. All entries must be received by the end of the Sweepstakes Period to be valid. Incorrect or incomplete entries are void. Any attempt to obtain more than one (1) entry by using multiple/different email addresses,

identities, registrations or logins, or any other methods may void the entries and Entrant may be disqualified from the Sweepstakes. WINNER SELECTION

Brackets will be scored based on the scoring process set forth below:

- One (1) point for each correctly predicted match

At the conclusion of the Tournament, Entrants scores will be calculated, and prizes will be awarded as described below. In the event of a tie, ties will be broken in the following order:

1. Correctly guess the tournament winner
2. Number of points scored in Semifinal Round
3. Number of points scored in Quarterfinal
4. Earliest date/time of Prediction submission

Odds of winning will depend on the total number of eligible entries received for the applicable drawing. Winners will be notified by Sponsor via email on or about November 18, 2024. Each Entrant is responsible for monitoring his/her email account for prize notification and receipt or other communications related to this Sweepstakes.
