



Liability Waiver (COVID-19)



I acknowledge the contagious nature of Coronavirus/COVID-19 and the CDC and many public health authorities are still recommending social distancing.

I further acknowledge that Iceland of Hampton Roads (Iceland) & Hampton Roads Youth Hockey Association (HRYHA) has put in place preventative measures to reduce the spread of Coronavirus/COVID-19. I also acknowledge that Iceland or HRYHA cannot guarantee that I will not become infected with Coronavirus/COVID-19. I understand the risk of becoming exposed to and/or infected by the Coronavirus/COVID-19 may result from the actions, omissions, or negligence of myself and others, including but not limited to Iceland's staff and Iceland or HRYHA's patrons and their families.

I voluntarily seek services by Iceland & HRYHA and acknowledge that I must comply with all set procedures to reduce the spread while attending and/or participating.

I attest that:

- I am not experiencing and symptoms of illness such as cough, shortness of breath or difficulty breathing, fever, chills, muscle pain, headache, sore throat, or new loss of taste or smell.
- I have not traveled internationally within the last 14 days.
- I have not traveled to a highly impacted area within the U.S. in the last 14 days.
- I do not believe I have been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19.
- I have not been diagnosed with the Coronavirus/COVID-19 and not yet cleared as non-contagious by state or local public health authorities.
- I am following all CDC recommended guidelines as much as possible and limiting my exposure to the Coronavirus/COVID-19.
- I will abide by all verbal and written instructions given to me by Iceland of Hampton Roads and their employees.

I hereby release and agree to hold Iceland and HRYHA harmless from, and waive on behalf of myself, my family, my heirs and any personal representatives, any and all causes of action, claims, demands, costs, expenses and compensation for damage or loss to myself and/or property that may be caused by an act, or failure to act of Iceland or HRYHA, or that may otherwise arise in any way connected with any services received from Iceland or HRYHA. I understand that this release discharges Iceland and HRYHA from any liability or claim that I, my family, my heirs, or any personal representatives may have against the skating facility with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from, or in connection to, any services received from Iceland and HRYHA. This liability waiver extends to the ice-skating facility together with all parties involved with managing and directing Iceland and HRYHA. This waiver covers the 2020-2021 season.
