### UNFINISHED BUSINESS

**Motion #80:** (Cale/Bock) To approve the meeting minutes from 5/12/25

Payments/Financials- VA did a quick rundown of current financials.

There is still a total of \$3401.19 in the special Post Season account left over from 3 years ago (Martin U18/Nationals at Las Vegas). Per the Post Season Policy, this money now comes back to the general club account. SH proposed that PRVC purchase a new net system for Pronghorn Elementary. JC proposed that the money go towards jerseys for next season. This amount will be tabled for now.

The Board revisited the idea of paying Janie Rayback for her additional work for the home tournament that PRVC/CCVC hosts. After some discussion, the Board agrees that \$500 is a fair amount for this work. The overall payment to CCVC for the profits from this tournament has not been made yet. Due to issues that have arisen in the WYBA/CCVC organization, the Board feels it would be best to meet with PRVC's lawyer (Alison Gee) before a payment is made. SH will reach out to get this scheduled.

**Motion #81:** (Hastreiter/Bock) To approve the payment of \$500 to Janie Rayback for her work on the home tournament

The money from Hillius Photography has come in totaling \$362.00. SH received the check, VA will deposit.

Grass League is nearing completion and gift cards need to be purchased for the tournament winners on 6/30/25. There is one gift card leftover from last season so 12 additional gift cards for \$10 each need to be purchased from various local businesses (Ice Cream Café, Jersey Mike's, Quiznos)


