Education Stipends

The NAWGJ NorCal Board has approved the following individual educational stipends for the 2023-24 fiscal year:

- Dec. 3 2023, Region 1 Base Score Clinic (Los Angeles) - \$350 towards reg. fee/travel/meals
- June 27-30 2024, USAG National Congress (Minneapolis) - \$500 towards reg. fee/travel/meals
- Aug. 23-25 2024, Region 1 Congress (San Jose) - \$300 towards travel/meals costs
- Group registration for Region 1 Congress - each judge pays \$25, balance paid by NAWGJ NorCal
- Ongoing - New Judge Stipend \$250 towards uniform/code/test fees
