R.B.S.A. cannot predict or control any cancellations of the upcoming season, whether seen or unforeseen circumstances, including any force majeure event, including, but not limited to, any act of God, epidemic, pandemic, strike, war, riot, crime, or similar or related event, which may prevent R.B.S.A. from carrying out its season and participation of your child in any R.B.S.A. activities. Should the R.B.S.A. activities and league season be cancelled prior to the start of the season, any such refund will be issued to the maximum extent possible, but any incurred expenses for equipment, uniform costs, and any other fees or expenses occurred prior to such cancellation shall be deducted from any refund issued.

**Disclaimer for COVID and other Communicable Diseases:  
INFECTIOUS DISEASE WAIVER FOR R.B.S.A. PARTICIPATION**

In consideration of my child's or the candidate's participation in any and all Richville Baseball and Softball Association and league activities, practices, games, programs, and related activities and events, the undersigned understands, acknowledges, and agrees to the following:

1. My child, myself, and my family understand that participation involves the possible exposure to and illness from infectious and/or communicable diseases, including, but not limited to, COVID-19, MRSA, influenza, pneumonia, and other infectious or communicable diseases and viruses. Although R.B.S.A. and the leagues may adhere to and follow particular rules and requirements, and recommended guidelines, from state and local officials and health departments, to reduce the risk of possible exposure to such diseases and viruses, the risk of serious illness and death remains. I have the option, and will remove myself, my child, and my family from participation and immediately bring to R.B.S.A attention a violation of any rules, regulations, or conditions should I feel create unsafe participation.

I, for myself, my child, and my family, knowingly and freely ASSUME ANY AND ALL SUCH RISKS, both known and unknown, even arising from the negligence of the RELEASEES or others, and assume full responsibility for myself, my child, and my family for participation in any and all activities related to R.B.S.A and league activities.

On behalf of myself, my child, and my family, including my heirs, assigns, personal representatives, and next of kin, HEREBY RELEASE AND HOLD HARMLESS R.B.S.A, its board of directors, officers, officials, agents, members, leagues and associations, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct any event or activity, in which participate ("RELEASEES"), from against any and all claims, liabilities, damages, loses, and bodily, personal, and mental injuries, arising out of any participation and/or injury to the myself, my child, and/or my family, including but not limited to the, possible illness arising from any infectious or communicable disease or

virus, should myself, my child, and/or my family become ill, whether arising out of the negligence of RELEASEES or otherwise to the fullest extent permitted by law. This release is to be interpreted and intended to be as broad and inclusive as permitted by law. If any portion of this release is interpreted to be invalid, it is agreed that the remaining provisions and terms herein will continue in full force and effect to the extent permitted by law. This release will be governed and interpreted under the laws of the state of Ohio.
