

BRIGHTON BULLDOG FOOTBALL AND CHEER WAIVER/RELEASE OF SPORTS PHYSICAL

ASSUMPTION OF RISK / WAIVER OF LIABILITY / INDEMNIFICATION AGREEMENT

In consideration of being allowed to participate in Brighton Bulldog Football and Cheer (BBFC) programs and related events and activities of BBFC, the undersigned acknowledges, appreciates, and agrees that:

1. Participation with BBFC includes possible injury, illness, and/or aggravation of pre-existing medical conditions that may pose a risk of illness, harm, and injury, and that I understand that having my child undergo a physical examination with a licensed medical professional in the State of Michigan is best to understand and know if my child has medical conditions that may affect my child’s ability to participate in sports; and
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS of my not having my child undergo a sports physical on behalf of my child participant, both known and unknown, including susceptibility to injury, aggravation and injury of pre-existing conditions such as, including but not limited to, neurological, pulmonary, and cardiovascular conditions, exposure to infectious disease, and assume full responsibility for my participation and that of my minor participant in BBFC programs, events, and activities; and,
3. I, for myself, my minor participants and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS BBFC (“Releasees”) it’s representatives and agents, along with other BBFC participants, sponsoring facilities, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the activities or events WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, DEATH, or loss or damage to person due to participation with BBFC, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IF FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
